ORDINANCE NO. 1429

AN ORDINANCE MODIFYING CHAPTER 2 SECTION 2-203 OF THE CITY CODE FOR THE CITY OF MARION, KANSAS PERTAINING TO PROHIBITION ON OWNERSHIP AND KEEPING OF CERTAIN DOG BREEDS.

WHEREAS, The City has jurisdiction and exercises regulatory management authority over all animal control and regulations within the corporate city limits pursuant to the City Charter and State law. The City's purpose for exerting its management authority over the regulations pertaining to a prohibition on ownership and keeping of certain dog breeds is to protect the public health, safety and welfare.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MARION, KANSAS:

SECTION 1: Section 2-203 of the City Code is modified to read as follows:

2-203. Prohibition on ownership, keeping of certain dog breeds.

(a) It shall be unlawful to keep, harbor, own, or in any way possess within the city limits the following dog breeds:

- (1) Staffordshire bull terrier;
- (2) American pit bull terrier;
- (3) Rottweiler;
- (4) Any animal listed on the AKC Registration or DNA Testing as 51% or greater of the aforementioned breed shall be considered that breed for enforcement.
- (5) It shall be the responsibility of the owner to provide proof of breed at their expense through AKC registration or DNA testing.

(b) Any of the above prohibited dogs registered with the city on the date of publication of this article may be kept within the city subject to the standards and requirements set forth in section 2-207.

(c) There shall be a presumption that any dog registered with the city as a "pit bull", "pit bull mix", "Rottweiler", or "Rottweiler mix", is in fact a dog defined in subsection (a) above.

SECTION 2: This Ordinance shall take effect and be in full force from and after its adoption by the governing body of the City, approval by the Mayor and publication of a summary hereof certified as legally accurate and sufficient by the City Attorney.

ORDINANCE NO. 1431

AN ORDINANCE ESTABLISHING UPDATED RATES FOR ELECTRICITY SUPPLIED BY THE CITY OF MARION, KANSAS TO BECOME EFFECTIVE MARCH 15, 2018; REPEALING ORDINANCE NO. 1383.

BE IT ORDAINED by the governing body of the City of Marion, Kansas;

SECTION 1. That the rates of electricity furnished by the City of Marion, Kansas, to persons or corporations purchasing electricity from the City of Marion, Kansas, are hereby affixed according to the following classification of service and schedule:

BASE RATE

1. The residential base rate shall be \$12.00 for zero consumption and \$0.1298 per K.W.H. used thereafter.
2. The commercial base rate shall be \$14.00 for zero consumption and \$0.1298 per K.W.H. used thereafter.

FUEL ADJUSTMENT

In addition to the Base Charge Rate provided for, there shall be charged an additional fuel adjustment charge which shall be the fuel adjustment cost per K.W.H. actually paid by the City or credited to the City for the preceding month to any other electrical producers or incurred by the City of fuel costs, which shall be prorated on the basis of K.W.H. used by purchasers.

SECTION 2. These rates shall become effective March 15, 2018.

SECTION 3. Ordinance NO. 1383 is hereby repealed insofar as same is inconsistent herewith.

THIS ORDINANCE shall take full force upon one publication of the ordinance summary in the official city newspaper, the Marion County Record, Marion, Kansas.
